


WADMIN21-0011 (Hyatt Regency Alchemy Conference)

Request

- This is a request for an administrative permit for an outdoor community event being hosted by Red Carpet Events for Hyatt Regency.
- Red Carpet Events is seeking to host The Entrepreneurs' Organization 2021 Alchemy Conference.
- The event qualifies as an "outdoor community event" under Washoe County Code (WCC) Section 25.272.
- WCC Section 110.310.20 requires an Administrative Permit for an outdoor event with 300+ participants.



Event Location

The event will be held at the Hyatt Regency Lake Tahoe on the cottage green just west of the Lone Eagle Grill.








Event Details


Event Details

- The dates of the conference are October 12-14, 2021, and the event hours will be approximately 8:00 a.m. to 11:00 p.m.
- Activities will include outdoor adventures, presentations, speakers, and dinner events.
- The applicant's intention is to hold the majority of the conference outdoors to mediate COVID-19 concerns. Portions of the conference may be moved indoors as dictated by colder weather.



Event setup on the Cottage Green

- Setup will occur on October 11th and teardown on October 15th.
- Originally planned to install a tent
- Tent will no longer be used





Event Details

- The Hyatt Regency is experienced with hosting conferences and events. The Hyatt will fulfill many of the conference needs.
- The majority of the attendees will be staying at the Hyatt.
- Parking will be provided by the Hyatt. Valet services are also available.
- Food and beverages will be served by Hyatt catering.



Security and Sanitation

- Security will be provided by the Hyatt.
- North Lake Tahoe Fire Protection District (NLTFPD) provided conditions requiring a Public Safety Plan and a medical standby agreement.
- Sanitation facilities will be provided by the Hyatt. Existing restrooms are located at the Lone Eagle Grille. An executive restroom from Quick Space with 4 stalls will also be provided.
- Cleanup and trash removal will be carried out by Hyatt staff.


