Dave Zeigler, an Incline Village resident and member of the Incline Village/Crystal Bay Citizen Advisory Board (CAB), is sponsoring a Community Forum to discuss residential and commercial lighting in the Incline Village/Crystal Bay areas. All interested residents, property owners, citizens and members of the Incline Village/Crystal Bay CAB are invited to attend.

The forum will focus on the economic advantages of lighting choices and potential changes to lighting regulations. Multiple presenters from NV Energy, lighting professionals, a local engineer, and the *North Lake Tahoe Bonanza* will speak. There will be a question and answer period following the presentation. Some of the topics that may be covered in the presentation include: LED street lighting, lighting issues for the Lake Tahoe basin, scenic thresholds, environmental improvements with innovation, the Dark Sky concept, some points on the economy of lighting choices and heat/lighting differences of the various sources, and an overview of ordinances from other mountain communities explored by the Lake Tahoe Nuisance Working Group and the proposed draft Nuisance Ordinance, including a single point of contact for reporting County Code complaints.
