Items for possible action. All numbered or lettered items on this agenda are hereby designated **for possible action** as if the words "for possible action" were written next to each item (NRS 241.020), except for items marked with an asterisk (*). Those items marked with an asterisk (*) may be discussed but action will not be taken on them.

Possible changes to the agenda order and timing. Discussion may be delayed on any item on this agenda, and items on this agenda may be taken out of order, combined with other items and discussed or voted on as a block, removed from the agenda, moved to the agenda of another later meeting, and/or moved to or from the consent section. Items designated for a specified time will not be heard before that time, but may be delayed beyond the specified time.

 - A.* North Demonstration Project Karen Mullen, Project Manager for the North Demonstration Project will be giving an update on the North Demonstration Project (Route 28 Corridor Management Plan and Nevada Bikeway Project) and how the private and public sectors are working together to improve the safety, environment and recreational situations along this area.  - B. Special Use Permit Case No. SB12-002 AT&T Mobility, Incline Village High School, Wireless Communication Facility Review and recommendations on the request to replace an existing stadium light pole and replace it with a wireless communication pole including 12 panel antennas and ancillary equipment, and construct an equipment shelter within a 26' x 18' fenced area. The parcel is located a the sports stadium at Incline Village High School, 499 Incline Village Boulevard, approximately 400 feet north of its intersection with Northwood Boulevard, Incline Village (APN 124-071-52) and is 19.01 acres in size, is zoned Public and Semi-Public Facilities (PSP), and is located within the Tahoe Area Plan. This request is Authorized in Article 324, Communication Facilities and Article 810, Special Use Permits in the Washoe County Development Code, is in Commission District 1, within Section 15, T16N, R18E, MDM Washoe County, NV.
