- 6.\* PUBLIC COMMENT: Comment heard under this item will be limited to items not on the agenda. Public comment and/or testimony, as applicable, will also be allowed under each individual agenda. Any time limits for this public comment item and for public comment/testimony during an agenda item will be set by the Chair at the beginning of the meeting, but the time limit per person shall be no less than three minutes. The Chair may also grant additional time for persons representing a group at the beginning of the meeting. Testimony during an agenda item shall be limited to the subject of the agenda item. - 7. NEW BUSINESS (The staff contact listed on items for Community Development may not be in attendance but can be contacted with code and policy questions.)

- A. City of Reno Special Use Permit Number LDC10-00059 (DP Silver Lake) Review and recommendations on a request to allow: (1) non-residential development adjacent to residentially zoned property (situated within Washoe County), and (2) disturbance of a major drainageway. The three parcels (APN 90-040-35, 38 and 39), totaling 204.37 acres, are located ±400 feet northwest of the intersection of Moya Boulevard and Lear Boulevard in the Industrial (I) zone within the City of Reno. The project will consist of a ±58-acre industrial site containing two buildings totaling 1,323,000 square feet (concrete tilt-up), most likely to be utilized as warehousing/distribution. Approval of the SUP will result in re-approval of previously approved SUP No. LDC07-00406 (with some modifications to the building size) which expired due to conditional time requirements. Ryan T. Sims, P.E. from Odyssey Engineering, on behalf of property owner/developer DP Partners, will be present to review the request and respond to questions from the citizens and CAB members. This application is tentatively scheduled for the October 6, 2010 City of Reno Planning Commission meeting. - B.\* DC11-00004 (Sky Vista Parkway Wal-Mart Center) Review on the request for a special use permit to allow: (1) cuts of 20 feet or more and fills of 10 feet or more; and (2) hillside development on a ±119 acre site located along the north side of Sky Vista Parkway ±225 feet west of its intersection with Lemon Drive in the CC (Community Commercial), LLR1 (Large Lot Residential 1 acre), SF6 (Single Family Residential 6,000 sq ft), and OS (Open Space) zones.   - A. Request from Washoe County Public Works for CAB Input for Potential Pedestrian and Bike Projects -Final review and recommendations on the request by Washoe County for input from the CABs to develop a list of potential pedestrian and bicycle projects to be located within public right-of-way of County maintained public streets. Washoe County has the opportunity to apply for Transportation Equity Act (TEA) enhancement funds later this year. Projects for this funding source are transportation related and not recreational. As TFA enhancement project funding is limited to \$650,000 per project, a relatively small amount for construction, it is recommended that projects be segmented in sections of ½ mile (2640 feet). In the past, Washoe County has been granted one project on a 2-year funding cycle. Although County staff will not be at the CAB meeting, questions can be directed to Clara Lawson, P.E., P.T.O.E., with Washoe County Public Works, by emailing her at Clawson@washoecounty.us or calling her at 775.328.3603. Currently, the NVCAB has previously recommended pedestrian and bike path projects on: along Cold Springs Drive: extend existing pedestrian and bike path along Lemmon Drive; path along Red Rock Road and extend existing pedestrian and bike path from White Lake Parkway to Village Parkway. During the July CAB meeting, the CAB discussed possible areas for future pedestrian and bike paths. During this CAB meeting, the CAB may take action on this topic to recommend either (A.) the top three community ranked priority pedestrian and bike path projects or (B.) forward all suggested projects for consideration.
