Amendment of Zoning Designation Lifestyle Homes TND LLC Review and recommendations on the request by Lifestyle Homes TND LLC to amend the City of Reno zoning designation of APN 566-010-12 from Large Lot Residential 1-acre lots (LLR-1) to Neighborhood Commercial (NC). The existing LLR-1 zoning designation of the property is currently not in conformance with the sites Urban Residential/Commercial Master Plan designation. The requested application will amend the sites LLR-1 zoning designation to Neighborhood Commercial (NC) which will bring the zoning of APN 566-010-12 into conformance with the existing Urban Residential/Commercial Master Plan designation. The property is annexed to the City of Reno and subject to the City of Reno development standards. The property is located at the northwest corner of the intersection of White Lake Parkway and Village Parkway, and at the northeast corner of the intersection of Village Parkway and Diamond Peak Drive.
