- 4. APPROVAL OF THE MINUTES OF THE MEETING OF NOVEMBER 9, 2010. Members of the public may submit proposed written corrections to the minutes of a CAB meeting to the CAB and must make copies available at the meeting for the public. The CAB may take action as part of this agenda item to include those proposed written corrections as part of the minutes.
- 5. Reaffirmation of Election of Chair At their July 6, 2010 meeting, the WSCAB elected Robert White as Chair for the 2010-2011 term of office. Because Mr. White was not present at the meeting, his election was subject to his acknowledgement. Although Mr. White indicated by e-mail to staff that he would be willing to serve as the Chair, the WSCAB will take action to reaffirm Mr. White's election on July 6 as the Chair for the 2010-2011 term of office.

 include, but are not limited to, the update of the Warm Springs Area Plan water budget and the citizen request to
 change the General Rural Residential (GRR) land use classification to General Rural Agricultural (GRA), as well
 as any topic residents wish to bring to the forum. (Note: The Community Forum is not sponsored by either
 Washoe County or the Warm Springs CAB.)

10. COMMUNITY FORUM UPDATE

- A. Update on Community Forum Held on December 6, 2010 Robert White, Chair, or others will report on the December 6, 2010 Community Forum, including community input on the Warm Springs Area Plan water budget and the request to change the GRR classification to GRA in the Warm Springs Area Plan, as well as discussion of possible allowed, permitted and not allowed uses within the proposed GRA land use classification. Following discussion, the CAB may make recommendations to Washoe County Community Development staff and/or the Washoe County Commission regarding these issues.
- 11.*PUBLIC COMMENT Time limits for Public Comment will be limited to 15 minutes. Any additional comments after the 15-minute time limit, will be continued following Item 14, Chairman/Board Member Items. Comment heard under this item will be limited to items not on this agenda and will also be limited to three minutes per person. Public comment and/or testimony, as applicable, will also be allowed under each individual agenda item and will likewise be subject to the same three minute limitation per speaker. Public comment/testimony during an individual agenda item shall be limited to the subject of the agenda items. Comments are to be made to the CAB as a whole.

The CAB follows NRS 241.035 and includes written remarks as part of the public record only when such remarks are read into the record and a copy is provided for inclusion as a part of the record.

- 12. NEW BUSINESS Time limits for these items will be limited to: 10 minutes for presenters, 15 minutes for public testimony, and 10 minutes for Board discussion. (Staff contact listed on items for Community Development may not be in attendance but can be contacted with code and policy questions.)
 - A. ADA-compliance complaint on the Truckee Meadows Fire Station #229 Discussion and possible recommendations to the Board of County Commissioners to permanently change the Warm Springs CAB meeting location, due to ADA issues resulting from an official complaint about the Fire Station and a pending ADA noncompliance determination from the State, and possibly change the permanent date and/or time to a different date and/or time as discussed at the meeting. Should the CAB recommend to the County Commission to change the meeting location, time and/or date, the CAB will bring the matter back to the March meeting for action. If approved by the CAB at the March meeting, the CAB will so notify the County Commission. If the Commission has no objections, the permanent meeting location, time and/or date will take effect with the May meeting. Staff has confirmed that the Library at the Lazy 5 Regional Park in Spanish Springs has a meeting room available the first Monday, every other month; however, the library closes at 6:00 p.m. If the CAB takes action to permanently change their regular meeting location to the Lazy 5 Library, the CAB should consider permanently changing the meeting time to 6:00 p.m. Should the CAB not change the meeting time to 6:00 p.m., a representative of the CAB will need to agree to be at the library prior to 6:00 p.m. to keep the facility open to accommodate the 6:30 p.m. meeting time.
 - **B.** Create standing item for Palomino Valley General Improvement District Updates: Discussion to have a standing item placed on the Warm Springs CAB agenda that would allow informational updates from the Palomino Valley General Improvement District (PVGID) to be discussed. The Warm Springs CAB Chair may designate a Warm Springs CAB member to act as "liaison" to the PVGID to ensure information sharing occurs on a regular basis.

 - A.* Warm Springs Area Plan Update Grace Sannazzaro and Bill Whitney with the Department of Community Development will continue the discussion on updating the Warm Springs Area Plan, a part of the Washoe County Comprehensive Plan. The Warm Springs Area Plan update process will be comprised of review and discussion over a period of several months that take place at regularly scheduled Warm Springs Citizen Advisory Board meetings. At the completion of the update, there may be revisions to any or all of the following sections of the Warms Springs Area Plan: Introduction, Conservation section, Land Use and Transportation section, Public Services and Facilities section, Conclusion, Appendix A Water Budget for the Warm Springs Area Plan, List of Maps and List of Tables. (This item is for information only and the CAB will take no action.)
