## BACKGROUND

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015, created Commission District Special Funds for each Commission District. On May 17, 2022, the Board of County Commissioners approved the 2022-2023 fiscal year budget with special district funds allocated per Commission District in the amount of \$100,000. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a non-profit organization, created for religious, charitable or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners,

directly or indirectly benefit any campaign efforts by a commissioner, violate Ethics in Government law, or be used to purchase tickets to special events.

Commissioner Hill, Commissioner Lucey, Commissioner Jung, Commissioner Hartung and Commissioner Herman have elected to support the following organization in fiscal year 2022-2023:

• [\$10,000.00] to the Commissioner Support Team – a government entity -- to support the Washoe County Academy Leadership Academy (WCLA) class project, The class project is intended for participants of the WCLA to "give back" or support their County/community by identifying a need within unincorporated Washoe County, issues that affect Washoe County residents, or relates to Washoe County local government and executing a project implementing a solution. The Washoe County Leadership Academy (WCLA) participants choose a project based on guidance from Commissioner Support staff and are required to give a presentation outlining the goals/objectives, timeline, outcomes, and sustainability of the project.
