



13. Unreasonable restrictions on competition under the award; association with federal government

 - B. Nothing in this condition shall be understood to authorize or require any recipient, any subrecipient at any tier, or any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.
- 14. Requirements pertaining to prohibited conduct related to trafficking in persons (including reporting requirements and OJP authority to terminate award)







- 32. Sub-recipient/sub-grantee agrees to have and keep all applicable liability coverages current.

- 33. This is a cost reimbursable award.
