

Ms. Landess Witmer's request does not disturb undeveloped land. The new indoor arena will not interfere with views enjoyed by surrounding residents. It does not interfere with road line of site since it sits well away from the road and below the embankment. An indoor arena will potentially decrease daytime noise because horse training activities will be conducted inside a building rather than an outdoor arena. In short, I support permission for Silver Circle Ranch to build an indoor arena in the same location as their current outdoor arena.


