Approval of Minutes

Chairman calls for additions or corrections. Hearing none he calls for a motion to approve the minutes as written.

Dawn Aragon so moves. Followed by a Christen Pratt second and a unanimous vote the minutes are approved as written.

Approval of Agenda

Chairman asks for any additions or corrections to the agenda. Marty Easter points out a correction to the supplemental sheet to Agenda 1. The last paragraph should read "One owner of the 5 replied" rather than "One owner of 3 of the 5 replied".

The Chair then asks for an addition to the agenda and subsequent agendas, being a call for public comment before the New Business item.

He then calls for other additions or corrections. Hearing none he calls for a motion to approve the agenda as amended.

David Ericson makes a motion which is seconded by Teresa Parkhurst. All in favor and the agenda is approved as amended.

New Business

A request has been made by the City of Reno to change the name of the Interstate 80 Frontage Road which runs adjacent to Interstate 80, lying between I-80 and Gold Ranch Casino in the Verdi area. This road serves as access to the casino as well as several other parcels south. It is felt such an action would improve services to these properties, including mail and parcel delivery and 911.

There are 5 owners of 9 parcels which would be affected by this action, 3 of which are owned by the Federal Government. Each owner was notified and asked to respond, stating that non-response would be considered as not in opposition to the action. One owner of the 5 replied saying they were in favor of the action.

Paul Rourke asks what the address on the business used to be. The coordinator did not know and could only tell him the business had been dormant for many years.

Paul asked if there were any street signs, stating he thought there was one. The coordinator confirmed he had seen one at exit No 1. Kimble asked if this was approved, who would put up the signage. Christen said that the city of Reno would supply the signs. Kimble noted that it is in NDOT's right of way. Marty said that he would contact NDOT. A motion was made by Christen Pratt to adopt the change. Motion passed unopposed.

The Chair asked if there were any other items of concern or comments. Hearing none, he said the next meeting would be on Thursday, April 16, 2015 at 2:30 pm. The meeting was adjourned.
