#### 5. Business Items:

## a. **Presentation on Park Districts NV AB379 – Karen Mullen-Ehly, Consultant at Karen Mullen-Ehly, Inc.**

Ms. Mullen-Ehly shared the legislative overview of the bill and what it means going forward for parks, trails, open space and recreation in the State of Nevada.

# b. Presentation on Washoe County Park Master Plan - Eric Hasty, Consultant at Wood Rogers.

Mr. Hasty gave an update on the status of the Washoe County Regional Parks and Open Space Master Plan. The intent of the Plan is to provide a clear and focused direction for the next 20 years. Plans specific to local parks, regional parks, as well as open space and trails already exist. This is a kind of umbrella plan that ties all of the parks, recreation areas and open space and trails together. This plan is also a living document to move forward with time. An inventory of each Washoe County park was prepared. The demographics of the area were also looked at as well as land use and growth.

# c. Presentation on economic impacts of Golden Eagle Regional Park – Tony Pehle, City of Sparks, Recreation Manager

Mr Pehle presented information on the amenities at Golden Eagle Regional Park, the size of the complex, the economic impact to the area, and the success to draw players from all over the nation. The complex offers, among other things, softball fields, baseball fields, bocce ball courts, basketball courts and, in the near future, batting cages.

# d. Update and possible discussion on Smoke-Free Parks with a report on status from each agency – City of Reno, Jeff Mann; City of Sparks, Tracy Domingues; Washoe County, Eric Crump.

Each jurisdiction gave an update on the status of the smoke-free park ordinance in their region. The City of Reno and the City of Sparks have recently passed an ordinance for smoke-free parks. Washoe County is currently amending the language in County Code Chapter 95. It is a very large project and has not been finalized. However, the existing language in Chapter 95 references the prohibition of smoking in parks.
