

INTRODUCTION

The TSK led Master Plan Team had the pleasure of working with the Washoe County Community Services Department, Nevada Department of Wildlife, Bureau of Land Management, and Washoe County Archery Community to plan for the future development and continued success of the Washoe County Regional Archery Facility. These stakeholder participants represented a broad range of interests in the facility and provided the planning team with a balanced perspective of the project's needs and goals. In addition to County and State staff, the stakeholders represented archery's diversity including the sport's two largest communities: field archery and Olympic style target archery.

Despite the challenges of 2020 and 2021, the Master Plan Team has conducted several stakeholder and agency meetings (planned and impromptu), two public meetings, on-site meetings and observations, and facility research. Through this process, we have come to a shared understanding and developed a general agreement about the path forward among the Regional Archery Facility stakeholders and arrived at a Master Plan that will serve the Northern Nevada archery community into the next decade. This document summarizes the outcomes of that effort.

The Regional Archery Facility Master Plan presented here is intended to serve as a guide for future development. While an order to the identified projects is proposed, the plan is intended to be adaptable to future funding opportunities and changes in use. The Master Plan also identifies which projects will require approval from the BLM or funding support from the Nevada Department of Wildlife to be realized. The proposed timeline accounts for the approval process and granting cycles as well as design and construction periods.



ABOUT

The Washoe County Regional Archery Facility is a public outdoor recreational archery range that serves the archery community of Northern Nevada and California. The facility is located on public land leased by Washoe County from the Bureau of Land Management under a Recreation and Public Purposes Lease. The current lease was renewed May 10, 2012 and will expire May 10, 2032. This lease is based on the 2006 Silver Arrow Archery Park Development and Improvement Plan, which was updated in 2012 when the lease was renewed. (see addendum)

The facility is operated by a local archery club, the Silver Arrow Bowman, under a use agreement with Washoe County. Archery amenities consist of a field archery course, set distance target course, broadhead target and capture pit, 3D target area, secure storage (conex), covered seating and single portable toilet.

GENERAL SITE DESCRIPTION

The Washoe County Regional Archery Facility (WCRAF) is located at 1255 Matterhorn Boulevard, Reno, Nevada. The 110 acre facility sits at the north end of Lemmon Valley, halfway between Swan Lake and Antelope Valley on the southwestern slope of Coyote Ridge. There is approximately 200' of rise across the site with an average elevation of 5500' above sea level. There are three distinct washes that follow the overall slope. Surface soils are generally fine grain sand to dusty with some exposed rock along the washes.

Located in the transition zone between the Great Basin and Sierra ecosystems, the WCRAF site contains a healthy mix of mature and young growth juniper and there is no evidence of recent wildfire activity. There have been recent wildfire fuel reduction efforts by Washoe County, and this helped maintain the overall quality of the site. Relatively free from invasive species such as cheat grass, the site is a good example of a mature native habitat.

The site does show signs of use and degradation of ground cover. There is significant trail braiding throughout the site from both foot traffic and all-terrain vehicles. As a result, normal annual ground cover and grasses are sparse. Given the type of ecosystem and the current drought, native vegetation is slow to recover accelerating the impact of site use. Use caused erosion is observable along the archery course and support trails.

FACILITIES AND ACCESS

The site is undeveloped with no permanent facilities located on site and no utilities (power and water) provided. Cellular phone/ data coverage is good to excellent based upon the provider. The site is a good candidate for solar electric system support by battery distribution. There is adequate solar exposure to meet the projected master planned site needs through solar power.

The entrance to the WCRAF is located four tenths of a mile east of Matterhorn Boulevard. Access to the facility is via Silver Arrow Range Rd, a one and a half and two way graded unpaved road. Road conditions are generally favorable and during dry weather the site is accessible to all but the lowest clearance vehicles with two exceptions: the entrance point from Matterhorn and a wash crossing at the halfway point. The transition from pavement to dirt at the entrance is prone to potholing which makes it difficult for lower clearance vehicles traveling onto Matterhorn Boulevard. The wash crossing also erodes and ruts which making it difficult for lower clearance vehicles to enter the site. The road is not readily passable by passenger and two wheel drive vehicles during and often long after rain and winter storms. Improving access to the site should be considered as an essential improvement.

EXISTING CONDITIONS

The WCRAF perimeter is defined by a wire cattle fence and vehicle gate. The fence serves two purposes: the prevention of cattle from entering the facility, and guiding hikers away from wandering into an active target range. The vehicle gate separates two parking areas. A lower parking area that is accessible at all times and an upper parking area that is accessible only during archery facility events and weekends. Two "vee" livestock excluder gates permit foot access from the lower parking area to the facility when the vehicle gate is closed. The parking areas are unimproved and poorly defined. There is evidence of vehicle encroachment in the surrounding landscape.

Park signage and wayfinding is minimal, with a Washoe County parks entrance sign near the vehicle gate and at the entrance points to the shooting courses. In general, the site requires familiarity of the facility to understand course layout and intended use. The entrance points to the set distance and field archery courses (links course) are marked, however, the trail from signage to the first shooting stand is ill-defined. Once on the course, target to target way finding is defined by a series of permanent "arrowhead" markers intended to guide the user along set paths. Trail braiding is present throughout the field course and to the novice user course navigation can be challenging. It was observed that the majority of weekday archers do not follow the set course, but choose specific targets for practice. This pick and choose use of the facility is a significant contributor to the trail braiding as well as a safety concern.

The 3D target course uses life-like targets for a realistic archery experience. There is no set course layout and target and shooting

stand locations can be varied to refresh the course. Currently, there is no signage defining the 3D course and the archer relies on construction tape "flags" tied to juniper trees for way finding. The 3D Target course is the least well-defined of the archery facility's amenities and would benefit from added organizational structure to promote safety and healthier landscape.

Archery range activities are supported by a number of small structures. These include:

Gazebos & Shade Structures – There are three shade structures located within the WCRAF. Two small metal shade structures for seating and gathering at the eastern end of the upper parking area. Each of these structure provides approximately 400 square feet of shelter. The larger of the two (16' x 24') is centrally located in a small gathering area and is the most usable. The smaller structure (12' x 30') is located at the edge of the gathering area abutting a row of junipers. The ground beneath this structure noticeably slopes and is difficult to access. The third structure is positioned near the upper end of the field course. This is a wood structure with a bare ground floor. The ground noticeably slopes, however, this does not appear to impact its intended use as a tournament support structure.

Storage Structures – There are three storage structures located within the WCRAF. Two 40' Conex units positioned to create a central equipment and storage yard and a 10'x16' storage shed. Additional site storage is open to view and loosely organized. The location and visibility of the storage units and site storage detracts from the visual quality of the site.

EXISTING CONDITIONS

Restroom Facilities – There are no permanent restroom facilities on site. There is a single "port-a-potty" located adjacent to the Conex units. For tournaments, additional facilities are brought to the site. The nearest publicly accessible restroom is approximately five miles at the corner of Limber Pine and Lemmon Drive.

ACCESSIBILITY

The WCRAF does not meet ADA requirements for access, however, as an undeveloped facility there is no requirement to do so at this time. Any future developments will require that the facility provide appropriate ADA access.

OBSERVED USE PATTERNS

During the course of the planning effort, the team has had the opportunity to observe the use of the site. We have made the following conclusions:

General Use – The site receives regular use throughout the week. Five weekday observations were made and on each occasion multiple users were seen using the facility. The majority of these were settling on one or two targets to practice specific shooting conditions. Observed weekday use ranged from 1 vehicle to 6 vehicles. Weekend use was significantly higher with Silver Arrow Bowman reporting tournament attendance ranging as high as 140 participants to regular weekend use averaging 40 users at any given time. **Weather Impacted Use** – Site use is affected by seasonal weather conditions. Most notably, winter conditions (snow and snow melt) which affect the ability to access or walk the site have the greatest impact. Other than the most extreme weather events, daily wind conditions do not affect usage. The site was not observed during periods of precipitation.

SITE QUALITIES

The natural qualities of the site are highly prized by the archery community who appreciate the "being in the field" quality of the WCRAF. Any future development should take care to maintain that quality. The site does provide significant views of Lemmon Valley, Stead, Swan Lake and the Sierras. Planning for future public facilities should take advantage of these vistas as an added site experience.



2006 IMPROVEMENT PLAN OVERVIEW

The 2006 Silver Arrow Archery Park Development and Improvement Plan served as the basis for the initial lease agreement between the Bureau of Land Management and Washoe County. That document outlined a five year plan that included the current Field and 3D courses as well as indoor facilities for target archery and education. To date, the first two years of the five year plan have been achieved.

The 2006 plan was updated at the time of the BLM lease renewal in 2012. The five year plan, originally outlined in 2006 was incorporated in the 2012 update and is largely unchanged. The 2021 Master Plan adopts many of the goals of the 2012 plan and organizes them in a fifteen year timeline that will be more attainable. The 2012 plan is included in this document for reference. The 2021 Master Plan refines the previous goals as well as introduces new goals that are consistent with the proposed use of the facility.

Washoe County, through its Department of Regional Parks and Open Space, is seeking a 10-year lease renewal of 110-acres of BLM property for use as a public archery range, commonly known as the Washoe County Regional Archery Facility [hereinafter, RAF] (see map Exhibit A). Washoe County's existing lease is scheduled to expire May 10, 2012, and it is the desire of the Department and project partners to continue operation for public use due to its popularity and recreational benefits to the community.

Currently, Washoe County subleases the operations and maintenance of the RAF to Silver Arrow Bowmen [hereinafter, SAB], a local private non-profit 501c3 organization. Attached (Exhibit B) is a current copy of their sublease agreement with terms. Washoe County is in contract negotiations with SAB and anticipates continued operations and maintenance of the RAF for a lease term concurrent with the County lease renewal.

Attached as Exhibit C is a four year development plan as proposed by the SAB. While the SAB has not been able to accomplish all of their goals related to enhancements of the RAF due to limited financial resources, Washoe County did receive a \$4,902.54 grant from the Nevada Department of Wildlife Hunter Education Program to purchase fencing materials on their behalf. The project was needed for wildlife protection, property boundary clarification, to ensure safe operations and avoid outside interference. The project is complete and was identified in the previous development plan as submitted with the 2007 lease application. The Management Plan as proposed by the SAB is attached as Exhibit D. Development and revenue items are further addressed in the terms outlined in Exhibit B.

The RAF is consistent with Washoe County's Park District 2A Master Plan and Open Space and Natural Resource Management Plan. There are no known environmental or cultural concerns as outlined in BLM EA-NV-030-05-20 and FONSI N75639 (2912) (Exhibit E).



EXHIBIT C **5 year Development Plan**

Year One

COMPLETED

1. Develop four, fourteen target loops on the upper 90 acres. Loops will be designed to work within the natural landscape with the primary disruption of the landscape begin target placements and marked trails leading from one target zone to the next. Each zone is figured in with a 30 degree safety zone factor to meet the National Field Archery guidelines. The targets will be figured at different distances, shooting lengths, with a built in overshoot safety factor. (Value or 336 straw bales to be compressed into 56 targets - \$1,344.00)

Year Two

- 1. Finish target loops and trails.
- 2. Set upper and lower pre-fabricated 8'x20' skid buildings used for range maintenance. (Range buildings are estimated at \$21,000.00. Volunteer labor)

Year Three

1. Improve parking area.

NOT BEGUN

2. Start on field archery range on the lower 20-acres. This will be an open target area with a single firing line for Field Archery applications and for educational uses.

Year Four

- 1. Start construction, lower 20-acres on 80'x120' indoor archery range with a training and classroom area. (Cost is unknown; however, anticipated grants from the Nevada Department of Wildlife Pittman-Robertson Hunter Education Grants is the anticipated funding source).
- 2. Construct hunter safety trails, lower 20 acres, for hunter safety education.
- 3. Complete field archery range.

Year Five

- 1. Complete construction of indoor range.
- 2. Complete hunter safety trails.

The range will be open to the public on a daily basis. The range will be a Washoe County Park facility and subleased to Silver Arrow Bowmen, acting as steward for maintenance and operations of the facility.

FEES:

Silver Arrow Bowmen collects tournament and league fees, with approval of the County and BLM, to cover costs associated with maintenance, operations and development of the range including special events. Fees will be used for target repair and replacement, general range maintenance, road grading, archery equipment and special events. Tournaments will include seasonal archery leagues as well as regional and possibly national archery competitions.

Agreement Terms are outlined in Exhibit B and describe roles and responsibilities of the County and Silver Arrow Bowmen, as sub lessee.

PUBLIC SURVEY

Following a public meeting held in February 2021, the Master Plan Team conducted an online public survey to gather additional data to inform the master plan process. A dedicated website was created to conduct the survey (see URL below) and between March 1, 2021 and April 30, 2021 there were 31 respondents.

Based on their responses, the survey consisted of a diverse range of individuals with broad interests in the sport of archery. While the majority of respondents identified as an archer there was not the same unanimity in the type of archery that respondents identified with.

The large majority of respondents are familiar with the WCRAF, however, more than 1/3 of the participants do not use the facility. That percentage rose to nearly 1/2 later in the survey when asked about use patterns for the WCRAF.

Of those who do use the facility, responses matched on site observations. 50% of those who use the facility do so during the week with a slight bias towards morning use. On site observations have indicated that the facility is regularly used throughout the week.

USER SURVEY

Response demographics show that 2/3 of the respondents were male and nearly 3/4 were between the age of 41-65. This indicates an older sport and the Stakeholders saw this as justification for the master planning of future education capacity for the WCRAF.

Lastly, when asked what improvements respondents would most like to see, there was a slight majority responding in favor of the creation of an ada accessible outdoor olympic and paralympic style target course closely followed by trail improvements.

In general, the survey results paralleled the goals of the project Stakeholders and can be seen as validating the outcomes of the master plan effort including the large growth potential to expand facility use.

USER SURVEY RAW RESPONSES

CONTEXT OVERVIEW

The following section documents the Washoe County Regional Archery Facility in its context including:

Regional Archery Facilities: The WCRAF is unique in its location and environment. This aspect of the facility as well as its accessibility to central California archers results in a facility that regularly draws archers from over 100 miles away. The regional nature of the facility (as opposed to local) is one of the driving factors for enhanced amenities.

Site Location: Illustrates the location of nearby communities to the WCRAF.

Major Road Access: As can be seen in this study, the WCRAF is somewhat limited in its access to the people of Washoe County and Northern Nevada. While long term plans do exist that will make the facility more accessible to the community, there are limited opportunities to address this in the short term.

Federal Lands Plan: The WCRAF is located on federal land leased to Washoe County. As can be seen, the majority of land to the south, east and north is also federally held land. To the northwest, however, this land is privately held which may impact some improvement options.



SITE CONTEXT

Tribal Lands Plan: The WCRAF is not located on tribal lands and none are adjoining the facility.

Zoning/Land Use: The WCRAF is consistent with county zoning located in Rural and/or Open Space land use designations.


Fire Risk Plan: The WCRAF is located on federal land which the County does not designate for fire risk, however, the County does identify the surrounding lands as High Fire Risk and it should be assumed that the WCRAF would fall under a similar distinction.

Related Services & Facilities: The WCRAF location is shown in relation to retail outlets and support facilities expected to be impacted by the success of the facility.


County Recreation Plan: The WCRAF shown in relationship to nearby County Parks and Open Space.

Climatic Site Analysis: As an outdoor sport, archery is affected by the local weather patterns. This analysis indicates annual wind patterns and solar orientation for the WCRAF.












ANNUAL PRECIPITATION





IMPROVEMENTS OVERVIEW

Working with County Staff, Project Stakeholders and the Nevada Department of Wildlife, the Master Plan Team identified four areas of future improvement for the Washoe County Regional Archery Facility. In broad terms these consisted of:

Access Improvement: Access to the WCRAF was identified as a critical improvement for the long term goals and success of the facility. These improvements included improved signage and way finding from US-395 to the WCRAF, improved on-site parking, and most significantly the reconstruction of the access road to permit year round access. Although nearly the entirety of the proposed access improvements would occur outside of the WCRAF boundary and the limits of this master plan they are included in this document for reference and in recognition of the impact these would have on the success of the WCRAF.

Existing Course Improvements (Priority 1): Washoe County Regional Archery Facility has been in existence in some form or another for over two decades. In that time it has built a reputation as a challenging and rewarding course, however, its current amenities and course condition have fallen behind its peer institutions. Reinvestment in the existing courses was seen as an essential aspect of the master plan and had unanimous support among the Master Planning Team and Stakeholders.



RECOMMENDED IMPROVEMENTS


Permanent Facilities for Education Activities (Priority 2):

Expanding the role of the WCRAF in archery education and hunter education was identified as an important opportunity for the facility to participate in the expansion of the sport and build ties with the Nevada Department of Wildlife. The construction of such facilities would open the WCRAF to novice/beginning archers as well as make the facility more accessible to all.

Develop Outdoor Target Archery On-site (Priority 3): Currently, the focus of the WCRAF is on Field and 3D Archery to the exclusion of other archery interests. Within the region there is significant demand for Outdoor Target (Olympic and Paralympic) Archery Facilities capable of supporting youth sports and tournaments. The master plan proposes the construction of facilities to support this aspect of the sport to build a larger and more cohesive archery community in the region.

The four proposed improvements are illustrated on the following pages.

Improving Accessibility: Improving access for all archers is a core goal of this master plan. It is the intention of the projects outlined under Access Improvement, Permannent Facilities for Education Activities, and Develop Outdoor Target Archiery On-site to make the sport of archery in Washoe County archers regardless of physical condition and provide ADA accessibility.

Currently, access to the Washoe County Regional Archery Facility requires passage through a Lemmon Valley residential development using neighborhood rather than arterial streets. In the course of developing this master plan, community residents express concern over the potential for increased traffic and the impact that this would have on their community. As can be seen in the diagram at left, there is no direct connection between Matterhorn Blvd. and Lemmon Dr. Traffic is required to take one of four small side streets to Waterash St. to then reach Lemmon Dr.




EXISTING TRAFFIC FLOW



The preferred solution would be to connect Matterhorn directly to either Lemmon Dr. or Chickadee Dr. allowing traffic to bypass Waterash St. and the other residential streets entirely. (Note: Sand Pit is not recognized as an established road) That recommendation is outside of the scope of this master plan, however, it should be noted that the Prado Ranch Development currently in the approval process would resolve this issue as it includes connecting Matterhorn Blvd. to Lemmon Dr. via a new arterial road.

MASTER PLAN IMPLEMENTATION

THIS MASTER PLAN PRESENTS TWO PATHWAYS FOR IMPLEMENTING THE IMPROVEMENTS OUTLINED IN THIS DOCUMENT.

Phasing Option #1 is based on the assumption that the proposed improvements are consistent with the use and recreational activities outlined in the 2012 Improvement Plan and BLM Lease. In this scenario, the improvement plan can be implemented without additional approval from the Bureau of Land Management or NEPA study.

Phasing Option #2 is based on the assumption that aspects of this improvement plan are not consistent with the 2012 Improvement Plan and will require NEPA study and revised R&PP lease agreement with the Bureau of Land Management.

The two implementation options are similar with the exception of the outdoor target archery course, Phase 3 in the Master Plan which has a later construction date in Phasing Option #2.

The two phasing options presented here illustrate the recommended order for individual master plan improvements. In most instances, the sequence of improvements is in order of importance as communicated by the stakeholder groups. Some improvements, such as the construction of a new parking area or structure, require longer funding cycles which are shown in the Phasing Option #1 & #2 timelines. Conversely, improvements which can be implemented over time such as enhancing the existing courses are shown with longer construction periods to illustrate the possibility that these could be an ongoing effort.

The scope of work associated for each improvement phase can be found in this section following the phasing timelines. Scopes of Work are general descriptions of the proposed improvement, the priority associated with that improvement, and a possible cost range for that improvement.

Infrastructure improvements discussed elsewhere in this document are not included in the scopes of work as they lie outside of the master plan boundary.

The Timeline Color Code indicates the type of work associated with the master plan improvements outlined in the phasing timeline and scope of work. The diagram to the right demonstrates how to interpret the phasing timelines. The length of each bar represents the period of time associated with that task.

1) The location shown for the Outdoor Target Archery Course (M) is illustrative and intended to show the approximate location of the facility for the purposes of this master plan. The determination of the final location will be dependent upon site engineering to ensure that all soil disturbances remain with the boundary of the Washoe County Regional Archery Facility.

2) The construction of the Outdoor Target Archery Course (M) impact the existing set distance course targets and shooting stations. It is the intention of this phase to replace the set distance course with the flat target course. This will allow for greater numbers of practice target shooters to participate at any given time. It is recommended that the status of the set distance course be revisited when the flat target course is designed to determine if a new location for the set distance course is desired rather than being incorporated into the flat field course.

3) The Outdoor Target Archery Course (M) is intended to serve both Olympic and Paralympic Archery and must meet ADA accessibility standards. Providing access to this facility for all archers is a key strategy in the growth of the Washoe County Regional Archery Facility.






